Mass Claims in Employment Arbitration after Epic Systems: Unintended Consequences and Unexpected Opportunities

The recent flurry of high-profile mass arbitrations following the U.S. Supreme Court's decision in Epic Systems Corp. v. Lewis and the expansion of the gig economy has generated intriguing developments, including innovative means by which potential claimants are reached, efforts by employers to modify or be released from arbitration requirements, approaches to coordinating without consolidating claims, responses from the legislative arena, and important court rulings, including the anticipated holding from the Supreme Court of Canada in Heller v.
